



## How do I setup Tax (GST) for Australia?

In Australia GST applies to Goods and Services at the rate of 10%.

Since GST applies to Services it means that it also applies to Shipping.

No tax applies to any goods exported outside Australia.

Tax is always included in the price.

Exceptions exist so if you are unsure visit [www.ato.gov.au](http://www.ato.gov.au) for more information.

This is how you set it up in ShopFactory.

1. Open your shop in ShopFactory , click -> Central -> Tax

2. Follow the steps in the diagram below

**Tax Wizard**

Here you enter the tax details and define, to which products the tax should be automatically applied.

- > **Name of Tax:** This tax name will be shown to your customers.
- > **Tax rate:** This is the tax rate you will charge in percent of the price. ShopFactory uses this rate to automatically calculate the taxes.

"Allow customers with sales tax exemptions to remove sales taxes from charge" is unticked (there may be exceptions)
